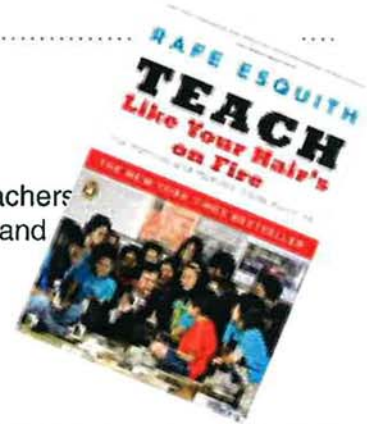

Rafe Esquith

A once-in-a-lifetime educator, Rafe Esquith may be the most inspiring school teacher in America. But they also play Vivaldi, perform Shakespeare, often score in the top 1 percent on standardized tests, and go on to attend the best universities. For his near-heroic work, Esquith is the only teacher to be awarded the president's National Medal of the Arts. He has received the National Teacher of the Year Award, and won accolades from Oprah, the Queen and the Dalai Lama. He's also written a bestselling book, *Teach Like Your Hair's On Fire*, and been featured, along with his students, in the PBS documentary *The Hobart Shakespearians*.

A joyfully creative and energetic teacher, Esquith delivers an unforgettable keynote -- an informal state of education address -- often accompanied by some of his students. He shares his methods for turning kids on to the wonder of learning, the power of the imagination, and the wealth of finding oneself. He touches on classroom issues (the best techniques for teaching various subjects, how to overcome budgetary constraints) and shows you how -- by teaching them hard work, kindness, and the courage to go one's own way -- his students have learned to adapt and to prosper in even the toughest of circumstances. Rafe Esquith is an upbeat, revitalizing speaker -- a must-see for anyone concerned with the future success of our nation's children.
